Town of New London Board of Commissioner's Meeting August 3, 2021

Mayor Tate Daniels welcomed everyone and opened the Commissioner's Meeting. Present for the meeting were Mayor Tate Daniels, Commissioners Bill Peak, Johnny Chestnut, Christy Starnes, Marcus Mullis and Town Administrator Susan Almond. Commissioner Kimmer was absent from the meeting. Visitors present at the meeting were Bill Rogers, Gary & Mary Robinson and Attorney John Scarbrough.

The Pledge of Allegiance was led by Commissioner Johnny Chestnut. Mayor Daniels asked if there were any changes to the agenda. Commissioner Mullis made a motion to approve the meeting agenda, seconded by Commissioner Starnes. Motion carried unanimously.

Mayor Daniels asked if there were any corrections or additions to the minutes from the July meeting. There being no corrections, Commissioner Mullis made a motion to approve the minutes, seconded by Commissioner Peak. Motion carried.

John Scarbrough, Attorney with Scarbrough, Scarbrough and Trilling, PLLC spoke to the Town Board about his practice and the services they provide.
